ORDER No.E5-202/2009/CE/LSGD Dated 30.12.2009

There are 477 Second Grade Overseers absorbed in Local Self Government Department Engineering cadre from different sources as optees from Public Works Department and Irrigation Department, compulsorily merged from Urban Affairs Department and Panchayath Department. As per the information gathered/received from different sources 2 second grade overseers from Public Works Department and 10 second grade overseers from Irrigation Department were not included in the seniority list published vide reference read as Ist. In the seniority list there are 465 Second Grade Overseer out of which 441 numbers have been assigned their rank. The service details of remaining 24 second grade overseers have not been received either from their parent Department or from the incumbents concerned.

Now 15 Second Grade Overseers from the listed 24 numbers have furnished their service details and requested to assign their rank in the seniority list. Also Sri. Ananthakrishnan. M, Second Grade Overseer has joined in the LSGD Engineering cadre as mentioned in the order read as Ist and now he has requested to include his name in the seniority list. Accordingly the rank of these 16 second grade overseers have been assigned in the seniority list and published through website “www.celsgd.com vide order read as 2nd”.

In the meantime 12 Second Grade Overseers have submitted representations requesting to re-assign their rank already given/including additional qualification etc. On scrutiny of the petition received from these overseers it is revealed that the rank assigned in the seniority list already published will have be changed in case of certain persons. As such the revised rank of these overseers were published through website www.celsgd.com vide order read as 2nd for obtaining objections if any from the

incumbents Smt. Mini Jose (Mini Jacob) has again filed a petition through her Executive Engineer vide letter read as 3rd requesting to reassign her rank based on the promotion order issued from the parents department. After scrutinising her petition with supporting documents it is also revealed that the rank already given from 393 to 398 will have to be changed and corrected accordingly.

Based on the above the seniority list of second Grade overseer is hereby finally modified and published.

The seniority list of junior most Second Grade Overseers/Draftsman absorbed in the LSGD Engineering cadre and newly recruited members through PSC after 01.01.2008 will be prepared and published in due course.


